## **Explanatory note**

The program of the entrance examination on the "World History (the XX century – the beginning of the XXI century)" is designed for foreign citizens applying to study for a Bachelor's degree according to the accredited educational programs and a Master's degree in Medicine.

The content of the program corresponds to the list of topics from the World History course for 10-11 grades of secondary schools of Ukraine (Історія: Україна і світ. 10-11 класи. Навчальна програма для закладів загальної середньої освіти. – Київ: HREC PRESS).

The program is designed to help clarify the knowledge of a foreign entrant knowledge of the World History at a level sufficient for successful studying in V.N. Karazin Kharkiv National University.

The Program is represented by the Department of Language and Specialized Training of International Education Institute for Study and Research of the V.N. Karazin Kharkiv National University.

## **Thematic Plan of the Program**

### **Introduction**

The subject of history. The main periods of the historical process.

#### 1. The world at the beginning of the XX century.

The main features of socio-economic development, state structure and political life of the world's leading countries (Great Britain, France, USA, Germany, Austria-Hungary, Turkey). The division of the world between colonial Empires. Creation of the Entente and the Triple Alliance.

#### 2. The First World War (1914-1918).

Reasons and reason for the outbreak of the First World War (WWI). Chronological framework of the war. The main theaters of military operations. End of the war. The main political and social results of the First World War.

#### 3. The world in the 20-30<sup>th</sup> of the XX century.

The post-war arrangement of the world. The Treaty of Versailles. Paris Peace Conference. The League of Nations.

United States. The growing role of the United States in the international arena. The Union of Soviet Republics (Soviet Union) as an imperial-type state. Political repression in the USSR.

The World Economic Crisis (Great Depression) of 1929-1933. Search for ways out of the crisis in the leading countries of the world (USA, England, Germany).

Formation of totalitarian regimes in Europe. The arrival of the fascists to power in Italy and Germany. Nazism. The ideology and policy of the Nazi regime in Germany.

Aggressive actions of Germany, Italy and Japan in the second half of the 30<sup>th</sup> years of the XX century. The Munich Conference of 1938. Negotiations on collective security in Europe.

#### 4. The Second World War (WWII).

The Causes and nature of the War. The main military actions in Europe, Asia, Africa, the Pacific. The main battle of the Great Patriotic War. The final period of the Second World War in Europe and Asia. The surrender of Germany, Japan and their allies. End of the War.

Political, economic, social results of the Second World War.

The creation of the United Nations (UN). Nuremberg and Tokyo international tribunals over war criminals.

Development of countries of Western Europe in the 50-90<sup>th</sup> of the XX century.

**Examination structure and evaluation criteria  
of the entrance examination  
on the World History  
(XX century – beginning of XXI century)  
for foreign citizens applying to study  
for a Bachelor's degree and a Master's degree in Medicine**

Examination control of knowledge of foreign entrants is carried out in the form of performance of test tasks and oral answers to the proposed questions in the ticket. The tasks of the entrance examination cover the entire period of the subject "World History (XX century, beginning of XXI century)". The total maximum number of points that an entrant can receive is 200 points.

1. Multiple choice test tasks. Entrant is offered a test that includes 40 questions, each of which is worth 2 points. The maximum number of points for this part of the task is 80 points.

2. The oral part of the entrance examination consists of answers to 3 questions. The maximum score for each question is 40 points. The maximum number of points that can be obtained for an oral answer is 120 points.

When answering each question on the ticket, the applicant must demonstrate the following knowledge and skills and receive the appropriate number of points:

1. Knowledge of historical events to the extent provided by the entrance examination program for the subject "World history (XX century – beginning of XXI century)" – from 1 to 8 points;
2. Understanding the socio-economic conditions of historical processes, the correctness and logical sequence of the presentation of the material – from 1 to 8 points;
3. Knowledge of historical chronology - from 1 to 8 points;
4. Knowledge of the geographical space in which historical events took place, skills use geographical and historical maps of the world – from 1 to 8 points;
5. Knowledge of the exam language, language culture, mastery of historical and social science terminology – from 1 to 8 points.

The number of points for one question is from 1 to 40.

The maximum number of points scored for the exam is 200 points.

A foreign entrant is allowed to participate in the competitive selection, if he received a score of at least 100 points.

Persons who, during the interview, did not show a level of knowledge corresponding to the listed criteria, are considered to have failed the entrance examination in "World History (XX century – beginning of XXI century)".
